**Proposal:-**

The Director, Technical Education vide aboverefined letter at Sr.No.1 to 4 have proposed to give approval of Government for new courses to increase in intke capacity of ongoing Courses in existent non granted institutions of Pharmacy in State, from the academic year 2021-22 and to issue Government resolution in accordance with the permission of Pharmacy Council India New Delhi.

From the academic year 2021-22 as proposed by the Director, Technical Education, as shown against the name of institutions in annexure "A" attached herewith, the issue regarding to give approval of new courses, to increase in intake capacity of the ongoing courses in existent non granted institutions of Pharmacy from the academic year 2021-22, in accordance with the permission of Pharmacy Council of India was under considernation of the Government.



**Government Resolution:**

In accordance with the approval of the Pharmacy Council of India, New Delhi, as proposed by the Director, as shown against the name of institutions in annexure "A" attached herewith, subject to the following terms and conditions the Government has issuing approval with respect to start new courses, to increase in intake capacity of the ongoing courses in existent permanent non granted institutions of degree and post graduate degree of Pharmacy from the academic year 2021-22,

1. This approval will be on permanent non granted basis.
2. In this regard, the institution concerned will be bound to fulfil the conditions as prescribed by the All India Council of Technical Education as well as as prescribed vide Government Resolution dated 21<sup>st</sup> May 1983. The intake capacity of the institute for this course will be as mentioned above.
3. The institute will have to enter into an agreement regarding acceptance of all the terms and conditions prescribed by the Government as well as all the terms and conditions as prescribed by the All India Council Technical Education, New Delhi / Pharmacy Council of India, New Delhi. Also the compliance of relevant documents and formalities will also be fulfilled satisfactorily with the consent of the Director, Technical Education, State of Maharashtra.
4. The concerned institution should pay the required accumulated deposit to the Director, Technical Education in a joint account and fulfil other legal matters.
5. Admission to this degree and post graduate course will be done as per the rules/procedure of admission of the respective course approved by the Government.
6. Action will be taken against the concern institutions in accordance with the Maharashtra Educational Institution (Prohibition and Capitation Fee) Act, 1987 if they charge more educational fees than prescribed by Fee Regulatory Authority.
7. The institute should appoint full time teachers and other Technical staff to run the Course as per Government rules. They should be pay salary and allowances to the staff as per rules. Strict action will be taken against institution in case of any complaint from teachers and other employees regarding Salary and allowances etc. as well as complaint received from the students.
8. The books, periodicals etc. required for library of the institute should be purchased as per the standards of All India Council of Technical Education. It is also necessary to provide study room facilities in the library for the students to make full use of the Library. As well as all educational facilities (for example Laboratory, Library, classrooms etc.) should be provided to the students as per the standards of All India Council of Technical Education.
9. It will be necessary to strictly implement the directions of the Honourable Supreme Court and the Maharashtra Prohibition of Ragging Act 1999 regarding ragging.
2. Apart from this, other terms and conditions laid down by the the Director, Technical Education, State of Maharashtra, Mumbai and the concerned university will be applicable.

3. Institutions which have not paid processing fees to the Director, Technical Education, State of Maharashtra, should recover the same before Director gives final approval and for the inclusion of the course in the centralized admission process, the Director, Technical Education should issue the necessary orders within next 10 days.
