4. Rate the content of syllabus in relation to load on the student?

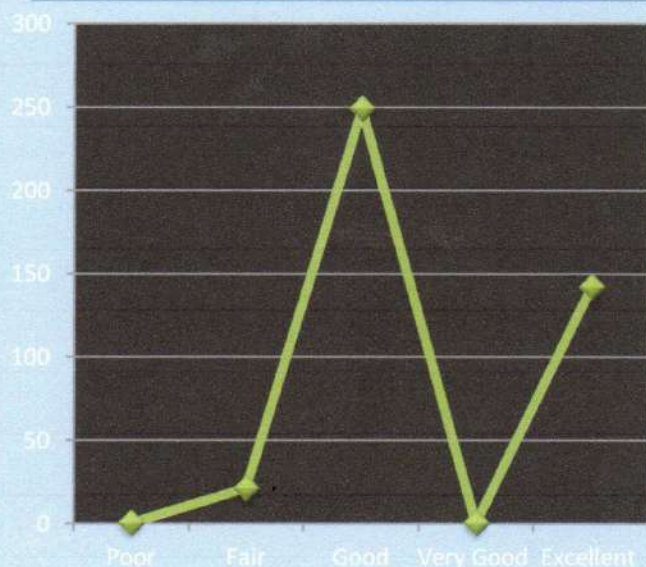

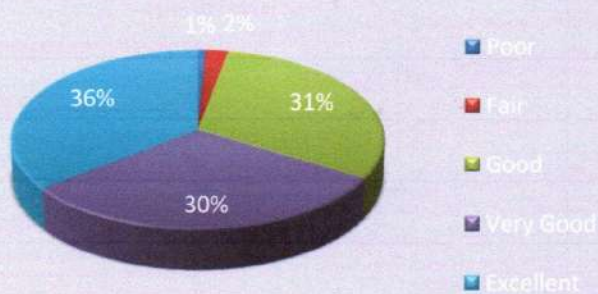

6. How do you rate the objectives stated and relevance to the course content?

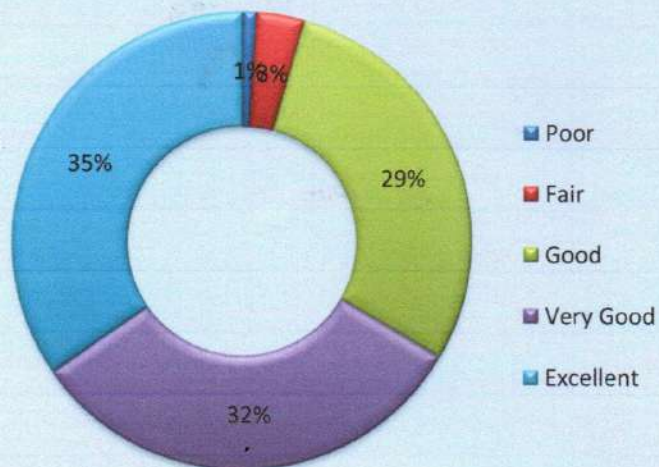

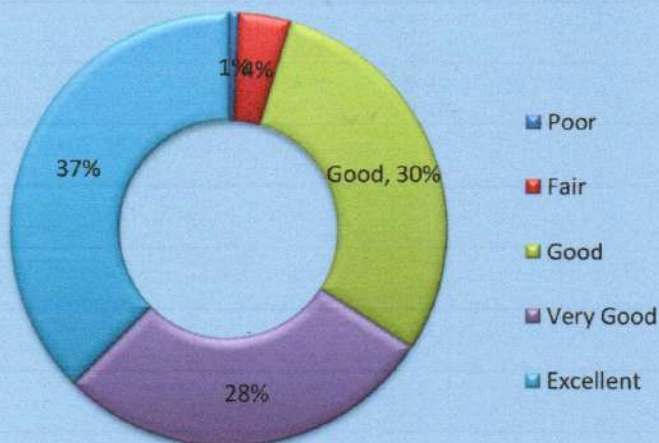

8. Required number of prescribed books are available in the library.

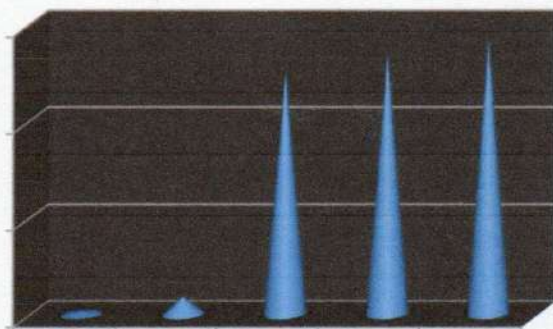

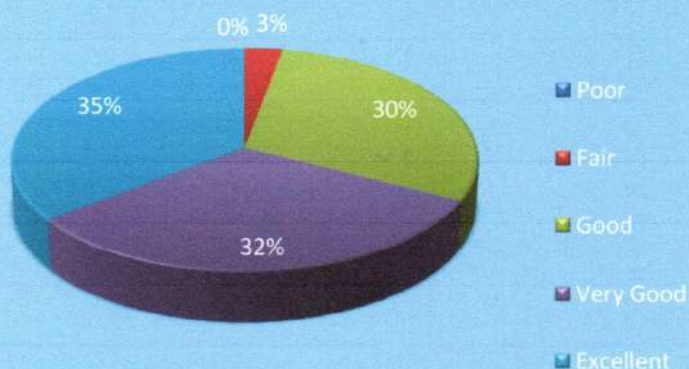

10. How do you propose the distribution of the Lecture hours among the course contents?

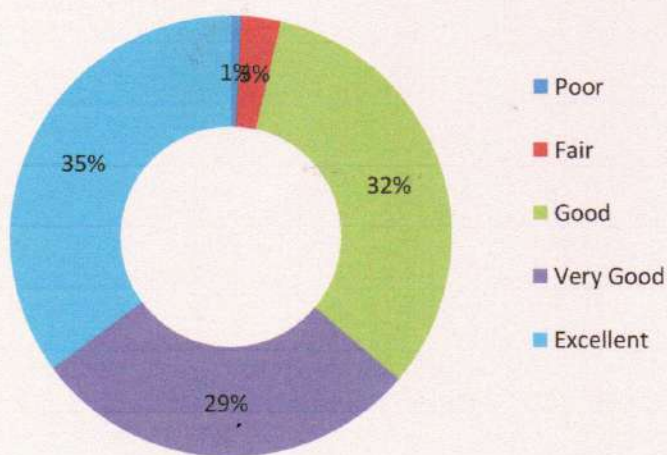

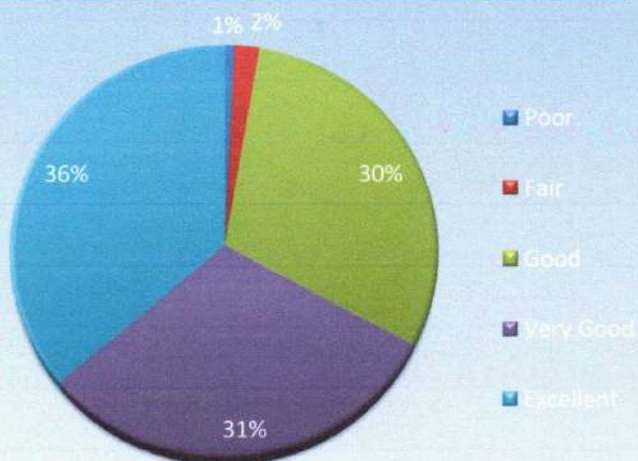
