- 4) As part of internal check and control in the Institute, Periodical rotation of work should be resorted by the management and report should be kept on record.
- 5) The figures are regrouped and rearranged wherever necessary.
- 6) It is advised that purchase procedure should be made online through e tendering especially tender publication, tender forms acceptance should be made online without manual interven

- 7) The Internal transaction between the college & other units & Sanstha are subject to reconciliation
- 8) The College must carry out all the financial transaction through RTGS/NEFT/ECS/UPI or through account payee crossed cheque
- 9) For petty expenses, management should regularly verify and sign all the vouchers/payment slips/cash book etc. so that effective monitoring will be there.
- 10) Bank reconciliation statement must be periodically prepared and all the corresponding entries must be reconciled with the books of accounts.
